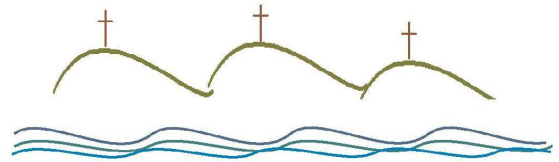

Dear Parishioners,

It is with heavy hearts that Fr. Cody and I write this letter. We have been notified by the Diocese that we will be changing assignments effective July 1, 2019. This will involve changes at our parishes.

Fr. Jeff is being assigned as Chancery Services Director, as Vice Chancellor and Adjutant Judicial Vicar for the Diocese of Helena, and as Administrator of St. Thomas the Apostle Parish in Helmville with St. Jude Thaddeus Mission in Lincoln.

Fr. Cody is being assigned Administrator of Holy Cross Parish, Townsend.

You may be wondering who will be coming to serve you. Fr. Brian Bergeron is being assigned as Administrator of Christ the King Parish. Fr. 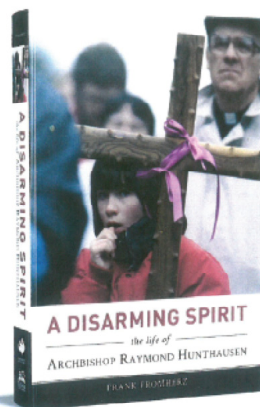
