Re: Priest Assignments, effective July 1, 2017

Parish and Deanery Realignment

Following upon recommendation of the Diocesan Personnel Board and after consultation with the College of Consultors and Presbyteral Council, I am making the following changes in parish configurations, effective July 1, 2017.

The Pastoral Care for Notre Dame Mission in Twin Bridges, Montana, is being transferred from the responsibility of the Pastor of St. Teresa of Avila Parish in Whitehall, to the responsibility of the Pastor of the Madison County Catholic Community (Ennis, Laurin, and Sheridan).

In order to allow for the appropriate coordination of pastoral care in the Diocese, St. Joseph Parish in Harlowton with its missions and St. Bartholomew Parish in White Sulphur Springs are transferred from the Bozeman Deanery to the Helena Deanery.

In order to allow for the appropriate coordination of pastoral care in the Diocese, St. Catherine Parish in Boulder with St. John Mission is transferred from the Helena Deanery to the Butte Deanery.

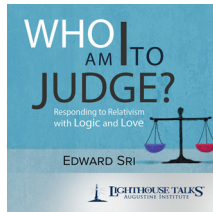

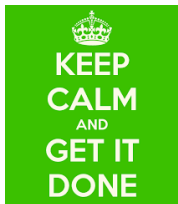


Has anyone ever told you to "Go Take A Hike"?




