

# Where does the money from "Take Out For Guatemala" go???

Here are just a few stories of people who are being served by the Clinica Maxena and your contributions.





The people of Guatemala are continuing to see greater poverty, hunger, and unemployment. There are few patients who can afford medicine and doctor consults. Clinca Maxena exists to serve the poor, so they are trying to make medicinal plants more available and inexpensive, which are a part of the Culture of the people they serve. Juan Guarchaj promotes medicinal plants and Reflexology and is a knowledgeable practitioner that has served the Clinica Maxeña since 1996. The clinic continues to maintain its Medicinal Plant Garden of over 100 Medicinal Plants and 22 Nutritive Plants.

FAITH IN PRACTICE, a religious, non-profit organization recently held a mobility clinic for communities of the region. There are many people in the area who are disabled and handicapped. Purchase of wheel chairs is impossible for most patients. Five patients from our area received new, durable wheel chairs adjustable for weight and growth. Magdalí, Director of Clinica Maxeña accompanied and transported our patients to the clinic.





Josue is a wonderful child of 11, who is suffering from CANCER and will have surgery next week. He will have a limb amputated at the pediatric cancer hospital in Guatemala City. He will be accompanied by a staff member of Clinica Maxena. He is a very happy and optimistic child from a small village near Santo Thomas, and in the 6th grade at his community school.



Magdalí, Director of the Clinica Maxeña, and Sheila visited a family, who are poor and the Mother died in child birth. The father looks for day work to support his family of five children. Magdalí is God Mother to the infant, Lorenzo. Lorenzo is part of our Nutrition Project for malnourished infants, who need support of formula and medical visits.


